	<ul style="list-style-type: none"> • Mono: Working on a flyer to be printed on postcard in English and Spanish to be delivered to all county PO boxes; child abuse reports have normalized but DV reports have been very high; county has moved to more restrictive tier due to COVID and anticipates child abuse reports to decrease; continuing to distribute resources at COVID popup test sites • Amador: Child abuse reports have normalized but DV calls have been consistently abundant during COVID; county has only one school district that has implemented a hybrid model, with some online and some in-person learning • Placer (North): Schools have implemented a hybrid model, but internet connection issues are causing challenges for children doing distance learning at home; child welfare cases are increasing, as well as domestic and substance abuse cases; printed “Celebrate Effort” stickers to distribute, as well as aspirational bookmarks <p>POVERTY SURVEY:</p> <ul style="list-style-type: none"> • Continuing to be mindful of what has been happening in our counties and how that can inform the strategic plan for the poverty assessment; how will COVID, stay-at-home, and distance learning affect data? <p>REMINDER:</p> <ul style="list-style-type: none"> • CBG 20/21 available now
